Guidance for Exhibitors:

Ingress and egress are to be conducted only during the scheduled times.

 Any special requests must be submitted to the EAS Congress Secretariat by 30 September 2018.
- Exhibitors are encouraged to consider the most environmentally friendly options for their booth, materials, promotional items, etc. For instance, the use of tarpaulins is discouraged (alternatives include paper posters, photo papers, sticker printing, photo canvas and cloth banners).
- One conference registration is included with each booth. Any additional staff must register as a conference attendee. Exhibitors are required to submit the names of their personnel assigned to staff the booth to the EAS Congress Secretariat. The booth must be staffed at all times.
- Exhibitor badges will be issued to the assigned booth personnel at the registration desk. For security and identification purposes, Exhibitors are required to wear their ID badges at all times while in the Exhibit Hall and around the Conference venue.
