TAN-LUC MARINE PROTECTED AREA

This is situated in Barangay Tando and Barangay Lucmayan, Nueva Valencia, Guimaras; hence, called Tan-Luc. It has a total area of 90 hectares, with a 10-hectare core zone. This marine protected area is managed by fisherfolks associations and co-managed by the Barangay Local Government Unit of Tando and Lucmayan. Having rich diverse coral reef area also makes this MPA vulnerable to Crown of Thorns (COT) and proves its resiliency in 2010 and 2015 during the COT infestation.



DOLORES MARINE AND FISH HAVEN

Barangay Dolores Marine and Fish Haven was established through Municipal Ordinance No. 2, Series of 2014 by the Local Government of Nueva Valencia, Guimaras. It has a total sea water jurisdiction of 56.51 hectares and established upon assistance from the Zoological Society of London. Currently, it is managed by the People's Organization and the Barangay Local Government Unit. It is one of the ecotourism destinations in Guimaras, having both natural resources and historical or traditional relic, the Guisi Light House.





GUISI LIGHT HOUSE

Guisi Lighthouse or *Faro de Punta Luzaran* is 18th century Spanish ruin located in Dolores, Nueva Valencia, Guimaras. It was first lighted up in 1894 and used to guide the mariners passing through Iloilo and Guimaras Strait. Now, it is considered as the province's pride as it claims the glory of being the second oldest lighthouse in the Philippines.
