PAMANCULAN FISH SANCTUARY

The Municipality of Sibunag established Pamanculan Fish Sanctuary as a marine protected area for marine biodiversity conservation through Municipal Ordinance No. 52, Series of 2014. This locally managed marine was established to benefit the neighbouring coastal barangay who depend on fisheries resources for their livelihood.

In 1999, the Municipality of San Lorenzo declared Tumulintinan Point waters as a Fish Sanctuary through Municipal Ordinance No. 99-005, Series of 1991. Tumulintinan Point Marine Protected Area is located at north-western coast of Guimaras Strait with an area of 363.72 hectares. It is characterized by patchy distribution of mangroves, seagrass, and coral reefs ecosystems and a sanctuary for high-value species, such as lobster and grouper. Due to its vast seagrass area, several sightings of dugongs "Dugongs Dugon" were recorded in the area.



SAN LORENZO WIND FARM

The project name is 54 MW San Lorenzo Wind Farm by the Phinma Renewable Energy Corporation with office address at Suclaran, San Lorenzo, Guimaras, 27 of these wind turbines stand tall in the municipality generating 54 MW of renewable energy hence its name.
